SENIOR

This Club Membership category is for applicants 19 and above as of April 1 of the current year. A Resident of the "Chester Golf Club Area" includes the Village of Chester and westward to the east bank of the Gold River and eastward to Highway 329 thence southward to the Little East River and Rous Cove including lands to the west of Highway 329 and those lands to the east directly abutting Highway 329 bounded to the north by Highway 103 and to the south by the Atlantic Ocean. Islands connected to the mainland are included. Any Resident living in the described Chester Golf Club Membership Area, ordinarily or seasonally, after a minimum of six months may apply for Club Membership.

Applicants whose Chester Golf Club Area residency is less than five years are subject to a one-time \$1500.00 plus applicable taxes Initiation Fee.

New Club Senior Members have thirty (30) business days from the date of their Club Senior Membership approval by the Club Membership Committee to pay their Senior Membership fees in full including the Initiation Fee if applicable. If full Senior Membership Fees are not paid within the thirty (30) business day period the Applicant will be added to the Club Membership Wait List and a new Senior Membership Application is required including a new \$100.00 non-refundable payment.

SENIOR SPOUSE

This is a courtesy extended by the Club to students continuing their education and who would otherwise qualify as a Senior Member at Senior rates.

JUNIOR/NOVICE

Applicants between the ages of 6 - 12 years (Novice) and 13 - 18 years (Junior) as of April 1 of the current year and is a child or grandchild of an existing Chester Golf Club Senior Member or a Resident of the Municipality of the District of Chester. Any Junior or Novice Member who maintains their Club Membership in good standing for a three (3) year period prior to turning 19 are eligible for Senior or Intermediate Club Membership upon reaching the age of 19.

SOCIAL

This Club Membership category is for Applicants wanting a social connection to Chester Golf Club. The annual Social Membership Fee is \$50.00 plus applicable taxes and provides Club dining room privileges and participation in the Club opening and closing non-golf functions. There are no boundary requirements for Club Social Membership.
