Member Account Privileges

- Members can charge purchases to their account at the Dining Room, Bar, Beverage Cart, and Pro Shop provided they have provided a chargeable credit card to the Proshop at the beginning of the season.
- ii) Charges at the Dining Room, Bar, and Beverage Cart that exceed \$10.00 will be subject to an automatic 15% gratuity unless otherwise directed by the member.

Accounts Receivable Policy

- i) No member account shall be set up until a credit card is attached to that account.
- ii) At month's end the account will be cleared via the credit card, unless paid previously.
- iii) In the event the club's staff is unable to access this credit card due to expiration, cancellation, or other reasons, the member account will be frozen until such a time as the account is cleared, or the card is re-activated.
- iv) Staff members may have a charge account without a credit card on file, with the firm understanding that any amount overdue will be deducted from their pay.
- v) All member accounts are to be limited at \$1000.00. There is to be no further credit until the account is brought up to date or a temporary increased limit is approved by the General Manager.
- vi) If a members account is overdue by 60 days playing privileges will be suspended until overdue accounts are cleared or satisfactory payment arrangements are approved by the General Manager.
- vii) All accounts must be paid in full before leave of absence or medical leaves are granted.
- viii) Any overdue account belonging to an ex-member shall be turned over to a collection agency, at the discretion of the General Manager.
- ix) If a member does not adhere to the club's A/R policy, the Board of Directors reserves the right to refuse future credit and playing privileges. Worst case scenarios may result in the revoking of membership by the Board of Directors.

Payment of Membership Fees

(i) Member account balances are to be settled monthly. Accounts not settled by December 31 of the year they were billed will result in suspension of membership.

Membership dues are due April 1. After April 1 unpaid dues are subject to a late payment penalty of \$150.00 plus applicable taxes. Any Senior or Intermediate member who has not paid their Membership dues and/or any outstanding Member Account balance as of close of business day May 1 will have their membership suspended for that entire season. Suspended Members may appeal prior to May 31 to the Membership Committee in writing, giving. reasons for the delay. If approved, the membership will be reinstated with an additional \$100. plus, applicable tax penalty. If not appealed or approved, the member will be removed from the membership list and can reapply through the usual process.

Medical Leave

- (i) A member may apply to the Membership Committee for Medical Leave for the upcoming season. The application must be made in writing to the Membership Committee Chairperson prior to April 1. The member's account from the previous year must have been fully paid by December 31. A doctor's certificate supporting the application must be included. The member will receive written notification from the Membership Committee Chairperson when their request is either approved or denied.
- ii) In the case of an unforeseen medical emergency, an application can be made as shown above. Membership dues must have been paid by April 1. If approved by the Membership Committee a refund will be provided based on the date of the application as follows:
- Before 1 May 100%
- Before 1 June 50%
- Before 1 July 25%
- After 1 July no refund will be provided.
- iii) Grace period In the event of a medical emergency, a up to a 2-week grace period following the injury/illness will be acceptable for submitting the application.
- iv) Rejoining during Medical Leave In the event that the member's medical circumstances change, following the approval of their Medical Leave request, the member may rejoin the Club during that year by paying the refunded amount.
- v)Members cannot be granted medical leave in consecutive years.

Leave of Absence

- (i) A member may be granted a leave of absence for 1 year to a maximum of 2 years upon application to the Membership Committee Chairperson.
- (ii) Payment of a \$100 fee plus any applicable taxes for each year is required.
- (iii) The Deadline for Leave of Absence request is April 1 of the year the request is submitted.
- (iv) The member will receive written notification from the Membership Committee Chairperson if his/her Leave of Absence request is approved or denied.

Senior Membership

- (i) Resident of the "Chester Area". This includes the Village of Chester and westward to the east bank of the Gold River and eastward to Highway 329, thence southward to Little East River and Rous Cove, 3 including lands to the west of Highway 329 and those lands to the east directly abutting Highway 329, bounded to the north by Highway 103 and to the south by the Atlantic Ocean. Islands connected to the mainland are included.
- (ii) Any person living in the described geographical area, ordinarily or seasonally, after a period of at least six months, may apply for membership.
- (iii) Qualified persons whose residency is less than 5 years will be subject to a \$1,500.00 initiation fee plus applicable taxes.
- (iv) New Senior Members have 30 days from the date of their Senior Membership application approval by the Club Membership Committee to pay their Senior Membership Fees in Full, including Club initiation fee if applicable. If full Senior Membership Fees are not paid within this 30-day period, the applicant will be removed from the Club Membership Wait List and a

new Senior Membership Application will be required including a new \$100.00 non-refundable Senior Membership deposit fee.

Senior to Social Membership

(i) The deadline for a member moving from Senior Member to Social Member is April 1, 2024. This request is to be made in writing to the Membership Committee Chairperson.

Intermediate

- (i) These persons are between the ages of 19 and 25 as of April 1 and are full-time students in a post secondary institution. Proof of student status must be provided.
- (ii) Dues are one-half of the Senior rate.
- (iii) This is a courtesy extended by the Club to students continuing their education and who would otherwise qualify as a Senior member at Senior rate.

Junior

- (i) Junior (ages 6-18) of the year Junior Membership Application is submitted
- (ii) Must be a child or a grandchild of a member or
- (iii) A resident of the Municipality of the District of Chester.
- (iv) Any Junior who maintains his/her membership, in good standing, for a consecutive three-year period prior to turning 19 will be eligible for Intermediate or Senior membership upon reaching the age of 19.

Social Membership

(i) This membership category is for those who wish to maintain a social connection with the Chester Golf Club. An annual fee of \$58.43, plus applicable taxes provides dining room privileges as well as participation in the opening and closing non-golf functions of the Club.
